

#### WHAT ARE THE GROW SMART AWARDS?

Idaho Smart Growth's annual Grow Smart Awards recognize projects or planning efforts that exemplify smart growth principles. Our awards program is a way of bringing Idahoans together to celebrate positive efforts communities are doing to create great places to live.

# Nominations accepted through July 1, 2015

To be eligible projects must be completed. Projects that are part of a larger plan may be more successful waiting until at least 50% of the larger plan is complete. Plans must be fully adopted by the city, county or appropriate body by the date the nomination is submitted. Winners are selected by a jury of professionals with a background in planning and/or development; community leaders; and one representative from the Idaho Smart Growth Board. Jury decisions are final. Jury members will not vote on any nomination in which they have a personal, professional, or financial interest.

Award winners will be recognized at the annual 2015 Grow Smart Awards Program held in Boise at the Owyhee on November 12.

#### **GROW SMART AWARD CRITERIA**

Nominations are evaluated using criteria based on smart growth principles listed below. Successful nominations will illustrate significant application of smart growth principles and be complete applications with ALL required attachments.

# Smart growth principles:

- Provide a variety of transportation choices
- Mix land uses
- Create a range of housing opportunities and choices
- Create walkable neighborhoods
- Encourage community and stakeholder collaboration
- Foster distinctive communities with a strong sense of place
- Make development decisions predictable, fair, and cost-effective
- Preserve open space, parks, farmland, natural beauty, and environmentally critical areas
- Strengthen and direct development toward existing communities
- Adopt compact building patterns and efficient infrastructure design

## **APPLICATION GUIDELINES**

Complete the cover sheet and respond to each of the ten questions (no more than 2 pages). **Please attach all requested supporting documents in the application checklist** and any other information that will assist the jury in understanding the context of this nominee including relevant policy/planning documents. Visuals such as site plans, elevations, photos and other supporting documents are helpful to the jury.

<u>All</u> documents must be submitted electronically. Please include a link for documents too large to submit electronically, i.e. comprehensive plans and longer documents, where jurors can view it. Please submit an executive summary plus a web link to the full document. Graphics submitted electronically should be included as a separate, attached file in bitmap (jpeg, tif, .png etc.) or .pdf format.

- 7. Photographs, drawings, or other information that illustrate the application of smart growth principles.\*
- 8. For comprehensive plans and larger documents, please provide an executive summary plus a web link to the full plan.

## **CATEGORY DESCRIPTIONS:**


- **Citizen Advocacy** any individual, group, or process that has exhibited excellent citizen advocacy and inclusion in development of a successful policy/plan/development project.
- Commercial or Industrial projects that are 90-100% commercial.
- **Green Building** recognizes the benefits of combining smart growth and green building approaches as building design and materials are integrated with land use and efficiency.
- Mixed Use development that provides a good balance of residential and commercial that provides
  opportunity for live, work and play.
- Public planning and policy fully adopted, policy or plan.
- **Redevelopment** any project that revitalizes an area and/or structure/s.
- **Residential** any project that is 90-100% residential.
- Small Community any project in a community with a population of less than 10,000.
- Transportation projects that enhance transportation choices, especially walking, biking or transit, improve
  connectivity, reduce reliance on single occupancy vehicles, provide context-sensitive design, complete streets or
  network improvements and/or reduce vehicle miles traveled through infill, mixed land uses, etc.
